Chris Kennedy is running for governor in in Illinois in 2018. Rauner budget debacle package of 13 bills includes change in pension plan, change in taxation and multiple other issues. This is the 3rd year running with an unbalanced budget. Lisa Madigan is still trying to stop pay for state employees. Standard & Poor have again downgraded Illinois.

Solidarity – Vickie Sumner (absent) – Vickie will be working with Edison's Entertainment to find out what \$100, \$200, or \$250 could provide to the union for the next general meeting. Lori made a motion to approve \$200.00 for the next General Meeting to be scheduled in March – date to be determined – location Edison's. Pam Cunningham seconded the motion. Passed unanimously. Pre-Negotiation Committee – It is recommended that a one year contract extension will be requested from the University. One item that Local 2887 does want to discuss regarding the contract would be targeted pay increases for different positions and increases to longevity.

Old Business - Goals for 2016

The current executive board needs to work on goals and accomplishments to leave the incoming officers in good shape. A "Lunch and Learn" was recommended by Kathleen Stipe – some topics could include "Right to Work" informationals, a refresher of what is in the current contract, and coordination of a town hall with Katie Stewart.

A goal to strive for would be an increase of full membership by 10% and consistent new member orientations.

Increased communication with the other union on campus should also be pursued.

New Business – The financial standards training for Trustees, President, and Vice President is scheduled for Saturday April 29th.

REPORT
It is our recommendation to the Executive board that we ask for a one-year contract extension. We believe the uncertainty of the current financial status of the state and university makes it extremely difficult to negotiate a fair contract for our members. Without the sure knowledge of the cost of health insurance premiums and co-pays that our members will be charged, our negotiating position is extremely tenuous, limiting our ability to properly protect our members' financial security. We also feel that with state universities such as SIUC, NIU and Eastern laying off and/or furloughing staff, it would be difficult to negotiate any clear advantages for our members at this time.
